

CONVICTION HIGHLIGHTS 2024



Joshua Charles Hebert

On February 21, 2024, Joshua Charles Hebert pled Guilty to the charge of Possession of Methamphetamine, a felony in violation of La. R.S. 40:967(C) and was sentenced to serve twelve (12) months in the parish jail. This case was investigated by Lake Arthur Police Department. Assistant District Attorney Burleigh Doga prosecuted the case against Joshua Charles Hebert.



Cyril Ellis Landry Prejean, III

On February 22, 2024, Cyril Ellis Landry Prejean, III pled Guilty to Possession of a Firearm by a Convicted Felon, a felony in violation of La. R.S. 14:95.1 and was sentenced to serve five (5) years at hard labor with the Department of Corrections. This sentence is to be served without probation, parole, or suspension of sentence. Any firearms that were seized at the time of the defendant's arrest are forfeited. This case was investigated by Welsh Police Department. Assistant District Attorney Burleigh Doga prosecuted the case against Cyril Ellis Landry Prejean, III.



Jarrett Reynauldo Matthews

On March 18, 2024, Jarrett Reynauldo Matthews pled Guilty to Attempted Possession of a Firearm by a Convicted Felon, a felony in violation of La. R.S. 14:25 & La. R.S. 14:95.1(B) and was sentenced to serve four (4) years at hard labor with the Department of Corrections. Any money, firearms, and/or contraband that was seized at the time of the defendant's arrest is forfeited. This case was investigated by Welsh Police Department. Assistant District Attorney Burleigh Doga prosecuted the case against Jarrett Reynauldo Matthews.

Shaquille Robert Joseph Landry

On February 22, 2024, Shaquille Robert Joseph Landry pled Guilty to the charge of Possession of a Firearm by a Convicted Felon, a felony in violation of La. R.S. 14:95.1 and was sentenced to serve five (5) years at hard labor with the Department of Corrections. This sentence is to be served without probation, parole, or suspension of sentence. Any firearms that were seized at the time of the defendant's arrest are forfeited. This case was investigated by Jennings Police Department. Assistant District Attorney Burleigh Doga prosecuted the case against Shaquille Robert Joseph Landry.



Vaughn Dell Robinson

On February 22, 2024, Vaughn Dell Robinson pled Guilty to Possession of Methamphetamine over 2 grams but less than 28 grams, a felony in violation of La. R.S. 40:967(C) and was sentenced to serve four (4) years at hard labor with the Department of Corrections. This case was investigated by Jennings Police Department. Assistant District Attorney Burleigh Doga prosecuted the case against Vaughn Dell Robinson.

CONVICTION HIGHLIGHTS 2024



Jacob Micah Allen

On March 14, 2024, Jacob Micah Allen pled No Contest to Sexual Battery, a felony in violation of La. R.S. 14:43.1 and pled No Contest to Domestic Abuse Battery, a felony in violation of La. R.S. 14:35.3(F). Jacob Micah Allen was sentenced to serve ten (10) years at hard labor with the Department of Corrections for the Sexual Battery Conviction. This sentence is to be served without benefit of probation, parole, or suspension of sentence. Jacob Micah Allen was sentenced to serve twelve (12) years at hard labor with the Department of Corrections for the Domestic Abuse Battery Conviction, with the first three (3) years to be served without benefit of probation, parole, or suspension of sentence. These sentences are to run concurrently; however, the sentences in this matter SHALL not run concurrent with any other sentence in which the defendant is currently serving. The defendant must register as a sex offender for 15 years, and a permanent stay away order will be put in place to protect the victim. This case was investigated by Kyle Klein with Jeff Davis Parish Sheriff's Office. Assistant District Attorney Torrie Thibodeaux prosecuted the case against Jacob Micah Allen.
