

AUGUST CONVICTION HIGHLIGHTS 2024



Douglas Francois

On August 7, 2024, Douglas Francois pled Guilty to Simple Burglary, a felony in violation of La. R.S. 14:62 and Home Invasion, a felony in violation of La. R.S. 14:62.8. Douglas Francois was sentenced to serve five (5) years with the Department of Corrections for Simple Burglary and five (5) years for Home Invasion, to be served concurrently. Derrick Lee Crochet

On August 7, 2024, Derrick Lee Crochet pled Guilty to Possession of Heroin less than 2 grams, a felony in violation of La. R.S. 40:966(C). Derrick Lee Crochet also had his probation revoked, and is serving three (3) years, with the sentences to run concurrently. Donovan Wayne Kratzer was sentenced to serve one (1) year with the Department of Corrections for Simple Burglary and one (1) year for Theft, to be served concurrently. Jamaric Raphael Alexander was sentenced to serve one (1) year with the Department of Corrections for Simple Burglary and one (1) year for Possession of Methamphetamine less than 2 grams, to be served concurrently. Javari Guidry & Jordan Legros

On September 16, 2024, Javari Guidry pled No Contest to Manslaughter and Aggravated Burglary, a felony in violation of La. R.S. 14:31 and La. R.S. 14:60. Javari Guidry was sentenced to serve thirty (30) years for Manslaughter and thirty (30) years for Aggravated Burglary with the Department of Corrections. These sentences shall run concurrently. This case was investigated by Travis Savoy with [Jeff Davis Parish Sheriff's Office](#). Assistant District Attorney Burleigh Doga prosecuted the case against Javari Guidry. The offense occurred in 2018.

On September 16, 2024, Jordan Legros pled Guilty to Manslaughter and Obstruction of Justice, a felony in violation of La. R.S. 14:31 and La. R.S. 14:130.1. Jordan Legros was sentenced to serve thirty (20) years for Manslaughter and thirty (35) years for Obstruction of Justice with the Department of Corrections. These sentences shall run concurrently. This case was investigated by Travis Savoy with Jeff Davis Sheriff's Office. Assistant District Attorney Burleigh Doga prosecuted the case against Jordan Legros. The offense occurred in 2018.
