

CONVICTION HIGHLIGHTS OCTOBER 2024

Kerry Joseph Cormier

On October 17, 2024, Kerry Joseph Cormier pled No Contest to Theft of a Motor Vehicle, a felony in violation of La. R.S. 14:67.26(D)(1) and pled No Contest to Theft of a Firearm, a felony in violation of La. R.S. 14:67.15. Kerry Joseph Cormier was sentenced to serve ten (10) years at hard labor for Theft of a Motor Vehicle and was sentenced to serve ten (10) years at hard labor for Theft of a Firearm with the Department of Corrections. This sentence is to be served without benefit of probation, parole, or suspension of sentence. These sentences shall run concurrently. This case was investigated by Benjamin Matte with [Jennings Police Department](#). First Assistant District Attorney Alexander Guinn prosecuted the case against Kerry Joseph Cormier.



Marcus Jurelle Nixon

On October 17, 2024, Marcus Jurelle Nixon pled Guilty to Possession of Fentanyl, with the Intent to Distribute, less than 28 grams, a felony in violation of La. R.S. 40:967(A)(1), pled Guilty to Possession of Cocaine, with the Intent to Distribute, less than 28 grams, a felony in violation of La. R.S. 40:967(A)(1), and pled Guilty to Possession of Methamphetamine, with the Intent to Distribute, less than 28 grams, a felony in violation of La. R.S. 40:967(A)(1). Marcus Jurelle Nixon was sentenced to serve five (5) years at hard labor on each count with the Department of Corrections. These sentences shall run consecutively for a total of fifteen (15) years. This case was investigated by Eduardo Mendoza with [Jennings Police Department](#). First Assistant District Attorney Alexander Guinn prosecuted the case against Marcus Jurelle Nixon.

Brandon Louis Fontenot

On October 17, 2024, Brandon Louis Fontenot pled Guilty to Possession of Methamphetamine with Intent to Distribute, a felony in violation of La. R.S. 40:967(A)(1)(B)(1)(a), and pled Guilty to Possession of Fentanyl under two grams, a felony in violation of La. R.S. 40:967(C). Brandon Louis Fontenot was sentenced to serve ten (10) years at hard labor for Possession with Intent to Distribute Methamphetamine and was sentenced to serve four (4) years at hard labor for Possession of Fentanyl less than two grams with the Department of Corrections. These sentences shall run concurrently. This case was investigated by Eduardo Mendoza with [Jennings Police Department](#). First Assistant District Attorney Alexander Guinn prosecuted the case against Brandon Louis Fontenot.

Traven Carter

On October 17, 2024, Traven Carter pled Guilty to Simple Escape, a felony in violation of La. R.S. 14:110. Traven Carter was sentenced to serve two (2) years at hard labor with the Department of Corrections. This sentence shall run consecutive to his revocation time. Brandon Raynell Gloston

On October 17, 2024, Brandon Raynell Gloston pled Guilty to Failure to Register as a Sex Offender, a felony in violation of La. R.S. 15:542.1.4(A)(1). Brandon Raynell Gloston was sentenced to serve two (2) years at hard labor with the Department of Corrections. This case was investigated by Sarah Fox with [Jeff Davis Parish Sheriff's Office](#).
